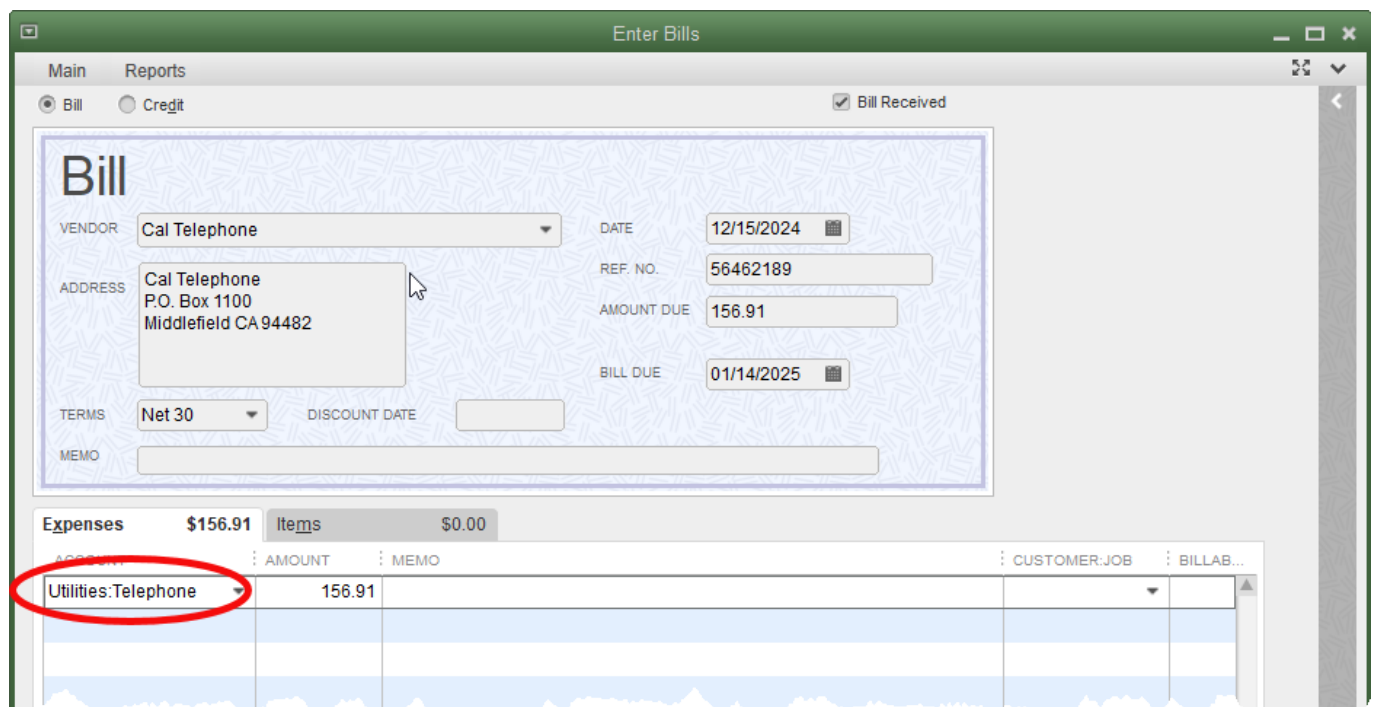

To pay your sales tax: • From the Vendors menu, go to Sales Tax, then select Pay Sales Tax.. DO NOT use Write Checks or Pay Bills windows to pay your sales tax to avoid errors in your bookkeeping and sales tax reports.. • In the Starting Check No Field, make sure the check number matches the next check you want to use.. If the list is empty, you may not have setup sales correctly • If you want to make a partial payment, go to the Amt Paid column then type the amount you intend to pay for each tax item on the list.. • The list shows all the sales taxes your company owes, the tax agency to which the sales tax is payable and the amount due as of the date in the sales tax due through.. • On the Pay From Account drop-down, select the checking account you want to use for the tax payments.

• Put a checkmark on the To be printed box if you need to print or hand write the checks later.. Before paying your sales tax, run a Sales Tax Liability report as it will provide information that you can use when you fill out your state/provincial sales tax forms.. If you want to check the sales tax transactions or add memos to them, you can view and edit them in the agency's sales tax payable account register..
